**Thursday, October 20, 2016** (all day long) – Gauteng Province

Two **business trips** have been planned on October 20, respectively to the North and to the South of the **Gauteng Province**, the economic and industrial heart of South Africa (about 35% of national GDP and 41% of national manufacturing Value Added).

Northern Gauteng business trip  
***“Discovering South Africa’s excellences:  
innovation hubs and automotive parks”***

This business trip has been conceived primarily for companies operating in the automotive sector. It includes a visit to the **Innovation Hub in Pretoria** (Technology Incubator Centre), established by the Gauteng Provincial Government in 2001 and Sub-Saharan Africa’s first internationally accredited and leading science and technology park.

From there, it will continue towards **Rosslyn**, with a visit to the **Automotive Supplier Park** (ASP), an automotive hub run by the Automotive Industry Development Centre (AIDC), housing various automotive component manufacturers, suppliers and service providers to OEMs including BMW, Nissan, Ford and Tata.

The visit will then continue at the **Automotive Learning Center** (a project launched in collaboration with Nissan), and at the facilities of **MA Group**. Return to Johannesburg is planned for around 4:00 pm.

Southern Gauteng business trip  
***“Leveraging South Africa’s socio-economic heritage:  
the role of new technologies, entrepreneurship and agribusiness”***

This business trip will include a visit to the **Soweto township**, the site of the historic student revolt in 1976 that was bloodily put down.

Following this, a visit to the **Sebokeng township**, where the **Southern Gauteng Science and Technology Park** is located, the campus of the Vaal University of Technology (VUT) - where research activity is carried out on 3D printing, advanced computing, agro-processing projects, and other technological fields. The visit will include a Workshop with young entrepreneurs who will present their case studies and business ideas.

The next stop will be a visit to an **agri-park** based into a township for fruit and vegetable production, an initiative promoted by the Gauteng authorities which are very committed to this project.
